

Mediation is a process not a "meeting"



- Mediation v Arbitration
 - Mediation (Med) strives to reach an effective compromise that permits a deal to be done
 - Arbitration (Arb) is a binding or non-binding decision handed down following a hearing of both sides
- Med/Arb is where no agreement with Med then move to Arb
- Arb/Med is where dispute is Arbitrated upon.
 Decision is not disclosed and Med is then attempted. If Med unsuccessful Arb is default.

Advantages of Mediation

- Faster than litigation
- Less expensive than litigation
- Informal compared to litigation
- Parties select the Mediator
- Parties decide who participates
- Parties determine the outcome
- Non-binding until agreement is reached
- Opportunity to vent emotions
- Creative solutions are possible
- Private
- Confidential



Disadvantages of Mediation

- One party can refuse to mediate
- Can't make legal precedent
- Discovery is non-existent or limited
- May still need adjudication
- Difficult if there is a power imbalance


Three Main Styles of Mediation



- FACILITATIVE mediators do NOT suggest solutions
- EVALUATIVE mediators evaluate & suggest solutions
- TRANSFORMATIVE mediators are not concerned about solutions. They want to "empower" and "transform" the parties

Plaintiff's View of the Case Defendant's View of the Case




Mediator's View of the Process

- 1. Getting the parties unstuck
- Get the first new offer
- A change in position or a shift of interests
- 2. Moving the bargaining along
- Generate significant movements in the positions
- Multiple concessions or the reformulating of Positions
- 3. Closing the gap
- Moving beyond original bottom lines
